Our Community-Based Mentoring Program is implemented following the Big Brothers Big Sisters model, which includes thorough screening of volunteers, in-depth interviews with children and parents, and professional support for the duration of the match. Research has shown that one-to-one mentoring can have a profound and lasting effect on young people, often changing the trajectories of their lives. Within the Community-Based Mentoring program, we serve several different populations, including children who come from homes where Spanish is the primary language and children whose families are impacted by incarceration. We also offer the Mentoring Towards College enhancement, is designed to promote on-time graduation and enrollment in post-secondary education. Through this program 97% of participants

The site-based mentoring program is a collaboration with corporations and schools to match children in one-to one mentoring friendships. Activities take place on school grounds, where children meet with their mentors on a weekly or bi-weekly basis. Matches focus on the academic, social or personal development, based on the needs of the child. We served 128 matches and made 37 new matches in 2018.
